1 Introduction

As part of the Smart Rural 21 project, the idea of using telemedicine applications was developed in Sollstedt in order to be able to counteract a foreseeable lack of resident general practitioners and to make the joint municipality more attractive for young doctors. In this context, the

Video consultation hours direct remote care of the patient by the doctor or psychotherapist, for example to save long journeys or in the case of basic immobility (e.g. after an operation). In this way it is possible, for example, to explain the treatment on the screen, to assess the healing process of an operation wound or to have a psychotherapeutic conversation. According to the Association of Statutory Health Insurance Physicians, medical practices have apparently increasingly offered this form of remote care during the Corona Pandemic.1 Previous experience indicates that video consultations can be a useful addition to classic consultations in the practice.2

On the question of which requirements must be met by the doctor in Thuringia, In order to be able to offer the video consultation as a billable service, empirica has carried out research, the results of which are summarized in the following sections.

Which actors play a role in the offer of the video consultation?

In principle, doctors in certain specialist groups have been able to offer video consultations at the expense of statutory health insurance since 2017 under precisely defined conditions. For this purpose, the doctor or psychotherapist selects a certified video service provider who ensures that the video consultation session runs smoothly. The providers must provide proof of IT security and data protection according to defined rules. The National Association of Statutory Health Insurance Physicians offers a list of certified video service providers who are allowed to offer the technical implementation of video consultations.3 On the part of the practices and the patient, a screen with a camera, microphone and loudspeaker as well as an Internet connection are essentially required. Additional software is not required.

As shown schematically in the following sketch (Figure 1), an application to the Association of Statutory Health Insurance Physicians in Thuringia is required if a doctor's practice would like to offer teleconsultation as part of contract doctor care. the

In Thuringia, people insured by three health insurance companies can currently use teleconsultation as part of contract medical care. A certified video provider can be freely selected by the medical practice. For this he has to

Video service providers have submitted a self-disclosure to the KBV and the National Association of Statutory Health Insurance Funds.4 After the contract has been concluded, the practice receives a certificate from the selected provider stating that the video service is certified in accordance with Annex 31b on IT security and data protection and that it meets the requirements for the content. The video service provider must also ensure that the video consultation is end-to-end encrypted throughout transmission.

What requirements does the doctor's office have to meet? 5

Details on the remuneration conditions are set out in the contractual agreements between the Association of Statutory Health Insurance Physicians in Thuringia and the respective health insurance companies (cf. Appendix). In addition, the legislator stipulates that medical practices must comply with general requirements:

- The patient must consent to the video consultation hand over.
- The video consultation must take place in rooms that offer privacy.
 In addition, the technology used and electronic data transmission must ensure appropriate communication.
- The video consultation must be confidential and uninterrupted like a normal office hours too.
- The real name of the patient must be recognizable for the practice.
- The video consultation must be free of advertising.

What services are remunerated?6

Doctors and psychotherapists were able to offer and bill unlimited video consultation hours during the corona pandemic, since the KBV and health insurance companies had lifted the corresponding restrictions. From April 2022, the number of cases and the amount of services will again be limited to 30 percent. In principle, different services are remunerated:

- · Basic, insured and consulting flat rate,
- Additional billable services,
- Surcharge for authentication of new patients,
- Technology and funding surcharge.

What organizational requirements are there for the medical practice?

The legislature places some requirements on the doctor's office in terms of the process or the implementation of a teleconsultation hour, the following must be observed:

Sick leave

Issuing a certificate of incapacity for work (AU) is in the Video consultation hour for both known and previously unknown Patients possible:

- up to 3 days: unknown patients
- up to 7 days: known patients

The prerequisite for this is that the symptoms allow for clarification via video consultation. However, there is no entitlement to this. A follow-up sick leave via video consultation is only possible if the patient was in the practice for a personal examination for the previous sick leave. Practices can charge a flat-rate postage fee for sending the certificate of incapacity to work (sample 1: GOP 40128 or sample 21: GOP 40129).

Corona special regulation until May 31, 2022: In the case of minor diseases of the upper respiratory tract, doctors can issue an AU for up to seven calendar days to known or unknown patients via video or telephone consultation.

Expiry

- The doctor or psychotherapist registers with a certified video service provider of their choice. The provider sends more Information on dialing into the video consultation at the practice.
- 2. The patient receives a free appointment for the video consultation either via the practice or for example in the case of an open consultation via the video service provider.
- 3. The patient must give their consent before the first video consultation depending on the system via the video service provider or directly via the doctor or psychotherapist.
- 4. The patient and the doctor or psychotherapist choose the video service provider. The patient waits in the online waiting room until the doctor or psychotherapist connects them.
- When the video consultation is over, both sides report from the website off. The doctor or psychotherapist documents the treatment in PVS.

Procedure for unknown patients

If the patient has never been to the practice before, they hold their electronic health card up to the camera so that the practice staff can check their identity and enter the necessary data (designation of the health insurance company; surname, first name and date of birth of the insured person; type of insured person; postal code of place of residence; health insurance number) can raise. The patient also verbally confirms the existence of insurance cover.
